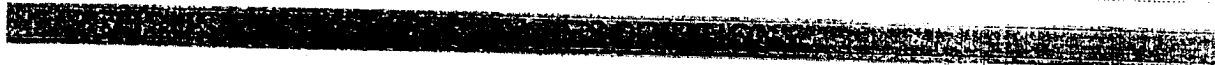

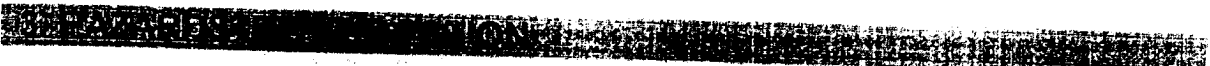

**A. EMERGENCY OVERVIEW:**

**Physical Appearance and Odor:**

**Acute Eye:**

**Handling:**

Avoid breathing dusts. Avoid direct or prolonged contact with skin and eyes. Use nonsparking tools and grounded/bonded equipment and containers when transferring. Avoid creating dusts as this product is pyrophoric in powder form.

**Storage:**

Store in tightly closed containers. Store in an area that is dry, well-ventilated, away from ignition sources, away from incompatible materials (see Section 10: Stability and Reactivity).

**Introductory Remarks:**

These recommendations provide general guidance for handling this product.
